

Contest Rules: 2025 National Hospitalist Day HM Voices Contest

No purchase or payment of any kind is necessary to enter or win.

The HM Voices Contest ("Contest") is sponsored the Society of Hospital Medicine ("Sponsor"). This contest is governed by these official rules ("Official Rules"). By participating in the contest, each entrant agrees to abide by these Official Rules, including all eligibility requirements, and understands that the results of the contest, as determined by Sponsor, are final in all respects. The contest is subject to all federal, state, and local laws and regulations and is void where prohibited by law.

ELIGIBILITY:

The Contest is open to legal residents of the U.S., who are eighteen (18) years of age or older at the time of entry. Employees, officers, and directors of Sponsor are ineligible to participate in this Contest. Sponsor has the right to verify the eligibility of each entrant.

CONTEST PERIOD:

The Contest begins on February 18, 2025, at 12:01 a.m. EST and ends on March 31, 2025, at 11:59 p.m. EST. ("Submission Period"). All entries (submissions) must be received on or before the Submission Period ends. Sponsor reserves the right to extend or cancel the contest at their sole discretion.

HOW TO ENTER:

All submissions to the Contest must be made via email to communications@hospitalmedicine.org. Entrants must share either a narrative (short story, poetry, creative writing piece, etc.) or graphic medicine submission (sketches, artwork, comics, etc.) related to the theme of "Advancing care. Building community. Creating opportunity." All submissions must be the original work of the entrant and must not have been accepted for publication in other journals, periodicals, or publications. Narrative submissions may not exceed 1,000 words. Each submission will count as one (1) entry. Entrants may enter as many times as they wish.

WINNER SELECTION:

Eligible entries received during the Submission Period will be evaluated by the Sponsor based on the demonstration of creativity and relation to this year's campaign theme, "Advancing care. Building community. Creating opportunity."

Three winners (the authors/artists of their narrative or graphic medicine submissions) will be selected following the Submission Period, resulting in a total of three (3) individual winners. Announcement of winners will be sent via email to the winner. Each entrant is responsible for monitoring his/her email for prize notification and receipt or other communications related to this contest.

If a potential prize winner cannot be reached by Sponsor within five (5) days, using the contact information provided at the time of entry, or if the prize is returned as undeliverable, that potential prize winner shall forfeit the prize. Upon the request of the Sponsor, the potential winner may be required to return an Affidavit of Eligibility, Release, and Prize Acceptance Form and IRS W-9 form. If a potential winner fails to comply with these official rules, that potential winner will be disqualified. Prizes may not be awarded if an insufficient number of eligible entries are received.



PRIZES:

Prizes will be awarded to three (3) winners. Each winner will receive:

Any attempt to damage the content or operation of this Contest is unlawful and subject to possible legal action by Sponsor. Sponsor reserves the right to terminate, suspend, or amend the Contest, without notice, and for any reason, including, without limitation, if Sponsor determines that the Contest cannot be conducted as planned or should a virus, bug, tampering, or unauthorized intervention, technical failure or other cause beyond Sponsor's control corrupt the administration, security, fairness, integrity, or proper play of the Contest.
